## Treasurer

## Committee Member

Job Purpose	The role of the Treasurer is to be responsible for the financial supervision and
	performance of the Club. The Treasurer is required to regularly report on the club's financial status to the committee to inform decision-making, mitigate financial risk, and ensure transparency for members.
Job Responsibilities	The primary responsibilities for the role of Treasurer are:
	<ul> <li>Coordinate the preparation of the annual budget for the forthcoming year, describing potential sources of income and expenditure, and present to the committee for approval.</li> </ul>
	<ul> <li>Maintain up to date records of all income and expenditure over the course of the year.</li> </ul>
	<ul> <li>Manage the club's cash flow including issuing receipts, depositing all monies received in the club's bank account and making payments promptly.</li> </ul>
	<ul> <li>Prepare and distribute invoices/accounts for services rendered.</li> </ul>
	<ul> <li>Provide a financial report at each committee meeting to support strategic planning and decision-making.</li> </ul>
	Submit BAS returns.
	<ul> <li>Manage payments for kiosk persons, youth instructors and water safety instructors in the MLSC School Beach Program if required.</li> </ul>
	Report financial activities to the membership at the AGM.
	<ul> <li>Act as the signatory on the club's bank accounts, cheque accounts, and investment and loan facilities (alongside President or Secretary).</li> </ul>
	Be fully informed about the financial position of the club at all times.
	<ul> <li>Prepare financial accounts for annual or more frequent auditing, and provide the auditor with information as required.</li> </ul>
	<ul> <li>Acquit funds received from government grants and submit the necessary financial statements where requested.</li> </ul>
	<ul> <li>Prepare all necessary financial statements for inclusion in the annual report including the Treasurer's report.</li> </ul>
	<ul> <li>Work with the Secretary and Club Administrator to keep accurate record of all membership payments.</li> </ul>
	Management of PayPal payments and reconciliation of funds in/out.
	<ul> <li>Submission of the Annual Financial Statements to the Charities regulator (ACNC)</li> </ul>
	Maintain the insurance renewal program with Marsh Insurance & LSV and submit any requisite insurance claims

	<ul> <li>Manage payment of the annual Patrol Hours Reward Program</li> <li>Management of bonds for the Board Rental Program</li> <li>Maintenance of BBQ and Kiosk floats</li> <li>Management of Club term deposits</li> <li>Responsibility for maintenance of Sponsorship arrangements in place (invoicing/agreements)</li> </ul>
